- Pays much attention to students' scientific work. Supervises scientific work of students. Ensures high-quality reports to be presented by students at students' scientific conferences at the university.
- A member of scientific-technical council.
- Awarded a certificate from Brest city administration, a certificate from Ministry of education of Republic of Belarus
- The total number of the published works equals 620. Among them 30 manuals, 590 works are of purely scientific character. After defending doctor's thesis 512 works were published, among them 11 manuals and 501 of purely scientific character. For the last 5 years 3 manuals were published, 192 scientific works, among them 42 articles are published in the editions belonging to list of journals recommended by Higher Attestation Commission of Republic of Belarus).
- Carried out the first in the scientific literature complex study of FRG policy in the sphere of limiting and reduction of armaments in Europe. The study embraces the whole period of existence of two separate German states.
- A systemic reconstruction of this policy enable this talented scientist to identify the specific attitude of Bonn republic to military and military-political NATO strategy, analyze its real role in working out NATO concepts of disarmament and control over armaments, to show internal and external determinants of FRG national policy formation,
- give a well-balanced assessment of Soviet-western German relationship in the period of discussing military-political aspects of building German unity, identify the degree

Brandt speech at the NATO Council session in Reykjavík (June, 1968), and give reasons for the significance of NATO scheme from December, 20, 1979, at the origin of which official Bonn was.</li> <li>• The scientist shows that federal governments initiated zero and intermediary variants, which were at the moment of their announcement by Americans to Soviet partners, serve the basis to escape missile crisis at the end of 1970-es.</li> <li>• In his publications a new productive approach to disarmament concept and control over armament of CSU, group “Channel-arbeiter” and Frankfurter group, acting inside SPD, a group inside CDU which A. Dregger, a group inside FDP, in which a key role was played by G.D. Genscher and O. Lambsdorff.</li> </ul> <p>This talented scientist has done a lot to overcome the stereotypes concerning German Christian political parties, which were observed for a long time in Russian Germanic studies. Michael Vasilyevich was the first scientist on post-Soviet territory who carried out a fundamental research to study the role of these parties in formation and development of social state in the FRG.</p> <p>The analysis of the attitude of power structures, the institute of civil society to non-titular ethnic group in the period, when Weimar Republic existed, has been performed by the professor.
